## NOTICE OF RACE

### 1. RULES

- 1.1. The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing* (RRS).
- 1.2. US Sailing Prescription 60, 63.2, 63.4 will be deleted.

### 2. ELIGIBILITY AND ENTRY

- 2.1. This regatta is open to all Star and Finn class boats that are in good standing with their respective class association.
- 2.2. Eligible boats may enter by submitting the entry form and paying the \$50 (Star) or \$25 (Finn) entry fee online at [www.nhyc.org](http://www.nhyc.org).
- 2.3. All entries shall be submitted on the Official Online Entry Form available at [www.nhyc.org](http://www.nhyc.org) not later than June 19<sup>th</sup>.
- 2.4. For the purpose of RRS Appendix A Scoring: A competitor is not considered an entry until all fees are paid.

### 5. MEASUREMENT

Crews shall demonstrate compliance with crew weight limits in accordance with STCR 31.1.3 during check-in.

### 7. VENUE

Racing will be conducted in the Pacific Ocean off Newport Beach

### 8. COURSES

Courses will be according to STCR 34.

### 9. SCORING

The Low Point Scoring System, RRS A, will apply, modified so that if four (4) or fewer races are completed, a boats series score will be the sum of her race scores.

### 10. PRIZES

- 10.1. For the Star class, the Baxter Bowl, a perpetual trophy, will be awarded to the winning boat in the Star Class.
- 10.2. Take-home prizes will be awarded to the top 3 boats.
