NOTICE OF RACE

1. RULES

- 1.1 The regatta will be governed by the *rules* as defined in the Racing Rules of Sailing.
- 1.2 For the Harbor 20 class only, Rules 44.1 and 44.2 are changed so that only one turn, including one tack and one gybe, is required.
- 1.3 US Sailing Prescriptions 63.2, and 62.4 are deleted.

2. ELIGIBILITY AND ENTRY

- 2.1. The regatta is open to all Lehman 12 and Harbor 20 boats.
- 2.2. Skippers must be members in good standing with their respective yacht club and their respective class association to be eligible to sail in this event.
- 2.3. The Harbor 20 fleet will sail in three divisions: A, B and C.
- 2.4. The L-12 class will be allowed to sail single-handed, however boats and crews must still meet class-mandated weight requirements.
- 2.5. Completed entry forms must be filed with Newport Harbor Yacht Club at www.nhyc.org before 1200 on September 30, 2018.

4. SAILING INSTRUCTIONS

Sailing Instructions will be available at the Newport Harbor Yacht Club on Sunday, September 30, 2018.

5. RACING AREA

Racing will be in the harbor north of the Main Dock of the Newport Harbor Yacht Club.

6. SCORING

- 6.1 One (1) race is required to be completed to constitute a series.
- 6.2 When four (4) or fewer races have been completed, a boat's series score will be the total of her race scores.

7. TROPHIES

- 7.1. Trophies will be awarded Sunday, September 30, 2018 as soon as possible after the last race.
- 7.2. The W.D. Schock Perpetual Trophy will be awarded to the first place boat in the Lehman 12 fleet.
- 7.3. The Corkett Perpetual Trophy will be awarded to the first place boats in the H20 A, B, and C Fleets.

8. DISCLAIMER OF LIABILITY

Sailing is an activity that has an inherent risk of damage and injury. Competitors in this race participate entirely at their own risk. See RRS 4, Decision to Race.
