NOTICE OF RACE

1. RULES

- 1.1. The regatta will be governed by the *rules* as defined in the Racing Rules of Sailing, including Appendix U.
- 1.2. RRS 44.1 and 44.2 are changed so that only one tack and one gybe are required.
- 1.3. US Sailing prescriptions 63.2 and 63.4 are deleted.

2. ELIGIBILITY AND ENTRY

- 2.1. The regatta is open to all female NHYC members, dependents, and spouses. The OA reserves the right to invite additional non-member competitors at its discretion.
- 2.2. The regatta may be sailed in up to three fleets A, B, and C. Competitors may enter as a Skipper, Crew, or 'Ride Along'. The OA will assign skippers to each fleet based on ability and input from the skipper.
- 2.3. The entry fee for this regatta is \$35 per person; this includes lunch, and post racing snacks.
- 2.4. Completed entry forms must be filed with Newport Harbor Yacht Club at www.nhyc.org by 1700 on June 7th.

4. SAILING INSTRUCTIONS

Sailing Instructions will be available at the Newport Harbor Yacht Club on Saturday, June 8th.

5. RACING AREA

Racing will be conducted in the harbor north of the Main Dock of the Newport Harbor Yacht Club.

6. SCORING

- 7.1 One (1) race is required to be completed to constitute a series.
- 7.2 When four (4) or fewer races have been completed, a boat's series score will be the total of her race scores.

7. TROPHIES

- 8.1 Trophies will be awarded Saturday, June 8, as soon as possible after the last race.
- 8.2 The Bettina Bents Memorial Trophy will be awarded to the winning crew.

8. DISCLAIMER OF LIABILITY

Sailing is an activity that has an inherent risk of damage and injury. Competitors in this race participate entirely at their own risk. See RRS 4, Decision to Race.
