**NOTICE OF RACE**

## 1 RULES

- 1.1 The regatta will be governed by the *rules* as defined in the Racing Rules of Sailing, including Appendix U.
- 1.2 For the Harbor 20 class only, RRS 44.1 and 44.2 are changed so that only one turn, including one tack and one gybe, are required.
- 1.3 US Sailing Prescriptions 63.2, and 62.4 are deleted.

## 2 ELIGIBILITY AND ENTRY

- 2.1 The regatta is open to all Lehman 12, Harbor 20 boats.
- 2.2 Skippers must be members in good standing with their respective yacht club to be eligible to sail in this event.
- 2.3 The Harbor 20 fleet will sail in three divisions: A, B and C.
- 2.4 The L-12 class will be allowed to sail single-handed, however boats and crews must still meet class-mandated weight requirements.
- 2.5 Completed entry forms must be filed with Newport Harbor Yacht Club at [www.nhyc.org](http://www.nhyc.org) before 1200 on April 27, 2019.

- 5.1 Racing will be in the harbor north of the Main Dock of the Newport Harbor Yacht Club.

## 6 SCORING

- 6.1 One (1) race is required to be completed to constitute a series.
- 6.2 When four (4) or fewer races have been completed, a boat's series score will be the total of her race scores.

## 7 TROPHIES

- 7.1 Trophies will be awarded Saturday, April 27, 2019 as soon as possible after the last race.
